**PUBLIC FINANCE MANAGEMENT ACT  
(CAP. 601)**

**Various Provisions relating to Public Procurement (Amendment)  
Regulations, 2022**

IN EXERCISE of the powers conferred by article 4 of the Public Finance Management Act, the Minister of Finance and Employment has made the following regulations:-

Citation.

1. The title of these regulations is the Various Provisions relating to Public Procurement (Amendment) Regulations, 2022.

**Part I**

2. This Part amends the Public Procurement Regulations and it shall be read and construed as one with the Public Procurement Regulations, hereinafter in this Part referred to as "the principal regulations".

3. Sub-regulation (1) of regulation 9 of the principal regulations shall be amended as follows:

(a) in paragraph (a) thereof, the words "one hundred thirty nine thousand euro (€139,000)" shall be substituted by the words "one hundred forty thousand euro (€140,000)"; and

(b) in paragraph (b) thereof, the words "one hundred thirty nine thousand euro (€139,000)" shall be substituted by the words "one hundred forty thousand euro (€140,000)".
